

MUNICIPALITY OF GINATILAN, CEBU

INVITATION TO BID FOR THE PROCUREMENT OF FUEL

1. The **Municipality of Ginatilan, Cebu**, using a **single year** for a duration of **six (6) months** Framework Agreement, through the **GF – MO (MOOE), 20% EDF (Roads & Canals) & 5% MDDRMF – CY 2021** intends to apply the sum of **Four Million Seventy Four Thousand Pesos Only (Php 4,074,000.00)**. Bids received in excess of the total cost per item shall be automatically rejected. Identification number per item and total cost being the ABC to payments under the contract for each item to be bid out are as follows:

2. The **Municipality of Ginatilan, Cebu** now invites bids for **Procurement of Fuel**. Delivery of the Goods is required within **each month**. Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary *“pass/fail”* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from **Municipality of Ginatilan, Cebu** and inspect the Bidding Documents at the address given below during **8:00 AM to 5:00 PM**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **May 25 to June 16, 2021** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos Only (Php 5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in the manner of presentation in person.
6. The **Municipality of Ginatilan, Cebu** will hold a Pre-Bid Conference on **June 2, 2021, Wednesday**, at **Ginatilan New Municipal Session Hall** which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **June 16, 2021, Wednesday at 1:00 PM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be on **June 16, 2021, Wednesday at 1:30 PM** at **Ginatilan New Municipal Session Hall**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **Municipality of Ginatilan, Cebu** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
