

WHEREAS, the Approved Budget for the Contract (ABC) as estimated by the Procuring Office amount to PESOS: THIRTY-SIX THOUSAND SEVEN HUNDRED THIRTY-FIVE PESOS (Php. 36,735.00) ONLY.


**Emergency Cases, Section 53(b) of RA No. 9184 and Section 53.2 of its 2016 IRR** shall be allowed in the following instances:

- when time is of the essence arising from actual or man-made calamities; or
- other causes where immediate action is necessary to prevent damage to or loss of life, property, or to restore vital public services, infrastructure facilities and other public utilities

WHEREAS, **GGPB Resolution No. 03-2020** - The instances or situations where the foregoing conditions may be applied include the provision of immediate response and initial recovery steps to avoid loss of life, injury, disease and other negative effects on human, physical, mental and social well-being, together with damage to property, destruction of assets, loss of services, social and economic disruption and environmental degradation.

NOW THEREFORE, on mass motion of all members present and duly seconded by the same, be it RESOLVED as it is hereby RESOLVED to recommend to the Municipal Mayor the procurement of the items contained in the PR through Negotiated Procurement (Emergency Cases).


