RESOLUTION NO. 3
Series of 2020

WHEREAS, presented to the Bids and Awards Committee (BAC) of Ginatilan, Cebu is Purchase Request No. 100 – 20 – 05 - 052 for procurement of the following.

Procurement of Supplies and Materials for the Fabrication of Swabbing Booth in the Quarantine Area

WHEREAS, the Approved Budget for the Contract (ABC) as estimated by the Procuring Office amounting to PESOS: SEVENTEEN THOUSAND NINE HUNDRED SIXTY PESOS (Php. 17,960.00) ONLY.

WHEREAS, Republic Act No. 11469 or the “*Bayanihan* to Heal as One Act” authorizes to undertake the procurement of identified goods and services as exemptions from the provisions of RA No. 9184 or the Government Procurement Reform Act in response to the Declaration of a State of National Emergency due to the Coronavirus Disease 2019 (COVID-19) outbreak.

WHEREAS, the Executive Secretary issued a Memorandum directing the Secretary of the Department of Budget and Management, who is likewise the Chairperson of the Government Procurement Policy Board (GPPB), to craft the guidelines for the conduct of procurement activities for the items exempted from R.A No. 9184 under the *Bayanihan* Act.

WHEREAS, the GPPB issued Resolution No. 06-2020 approving the Issuance of Circular No. 01-2020 providing the guidelines for Emergency Procurement under the *Bayanihan* Act (“Circular”).

WHEREAS, starting April 12, 2020, all Procuring Entities (PEs) may now undertake **Emergency Procurement** under the *Bayanihan* Act using the procedure and requirements provided in the Circular. The procedure is similar to those provided under Negotiated Procurement (Emergency Cases) under Section 53(b) of RA No. 9184 and Section 53.2 of its 2016 Revised Implementing Rules and Regulations (IRR) and directly negotiate or procure from a legally, technically, and financially capable supplier, distributor, manufacturer, contractor or consultant.

NOW THEREFORE, on mass motion of all members present and duly seconded by the same, be it RESOLVED as it is hereby RESOLVED to recommend to the Municipal Mayor the procurement of the items contained in the PR through Emergency Procurement under the *Bayanihan* Act.
